What will I need to bring to my appointment?

Proof of identity, Social Security Number or ITIN, income and tax documents, and your bank account information (if you have one). When you make your appointment, you will get more details.

What if I want to do my own return?

The IRS offers an online “**free file**” option to persons whose adjusted gross income is \$73,000 or less. To get started, go to [IRS Free File](#) for links to free online software options that guide you through the process.
